# DECENTRALIZED MARKETING

We strive to help build communities for SLP tokens (Decentralized Applications) & other crypto related projects using social media. HALAL COIN HC platform consists of social media outlets such as: Telegram, Discord, Twitter, Facebook, Instagram, Tik Tok, Twitch, and most importantly our monetized YouTube channel. This ecosystem is what makes our services unique and how our platform is decentralized by its "Tokenomic" ecosystem.

# HALAL COIN (HC) TOKEN

HALAL COIN (HC) is a SLP token built on the BCH Blockchain. Users will be rewarded HALAL COIN HC tokens by completing tasks and/or participating in HALAL COIN marketing services. The rewarding system will be based on the contribution efforts of the user and the current market value. Users will be able to trade HC tokens on a cryptocurrency exchange or hold HC tokens in their personal SLP wallet. HC tokens held in a personal SLP wallet address can receive airdrops of HALAL COIN HC if the tokens are eligible. Revenues from HALAL COIN HC marketing services will be converted into BCH and will be held in a secure address designated for the Airdrop supply. The Airdrops will occur at the end of each monthly cycle, rewarding those who are holding the HC tokens.

# TOKENOMICS

## TOKEN SUPPLY DISTRIBUTION:

10% = We will send to the active Members of this Group via the Daily Airdrop of HALAL COIN HC.

10% = We will be used to compensate specially those who contribute ideas and efforts to the development of the token.

5% = HALAL COIN HC we will be used for Tipping of users who are making an Impact in the Community until the allocation is Exhausted.

5% = HALAL COIN HC will be used to Reward our top Social Users!

70% = HALAL COIN HC will be kept as a Reserve for Future Marketing and Development Plans for the Token.

SMART CONTRACT FUNCTIONALITY HALAL COIN (HC) started as a SLP token and has now been swapped to a SLP token with smart contract functionality. The purpose of the smart contract is to complete our annual airdrops to all HALAL COIN (HC) token holders that are eligible. As of right now there is no need for staking, all addresses eligible for airdrops will receive the airdrops if they are holding the HALAL COIN (HC) in a personal SLP wallet address.

AIRDROPS Rewards will be distributed to all the token holders eligible to incentivize users to hold the HALAL COIN (HC) token. The airdrops serve as a generous gift to our loyal supporters. Any revenue generated from the growth of the community, sponsorships, & referral commissions will be held in the Airdrop Pool and will be distributed based on the amount of HALAL COIN HC being held in the SLP wallet address at the time of snapshot. The snapshot will occur at the end of every calendar month and the Airdrop will occur no later than the 7th day of each month. The timing of snapshot and airdrops will occur at random times during each scheduled period to avoid anyone from taking advantage of the reward system. HALAL COIN HC community is committed to the platform's long-term growth and success. All the core team members have committed to developing for the platform throughout the foreseeable future and have performance-base incentives tied into their agreements. Any community member can participate the airdrop rewards if they meet all the criteria outlined in this document.

# REWARD DISTRIBUTION

To help incentivize participation in obtaining more HALAL COIN (HC) by completing tasks, there will be a minimum holding requirement to be eligible to receive Airdrops. You can earn HALAL COIN (HC) by participating In the LIVE STREAM events via TWITCH & DISCORD. Community members can also earn HALAL COIN (HC) by completing tasks assigned by admin via TELEGRAM. The minimum requirement to receive Airdrops will increase every month. The minimum requirement was 1000 HALAL COIN (HC) to receive first Airdrop. This amount will increase to 5000 HALAL COIN (HC) for the 2nd round and will increase 1000 HALAL COIN (HC) each round after that until reaching the MAX minimum requirement of 100,000 HALAL COIN HC to receive Airdrops. Reward Distribution Breakdown: 1st round = minimum of 1000 HALAL COIN (HC) to receive Airdrop 2nd round = minimum of 5000 HALAL COIN (HC) to receive Airdrop 3rd round = minimum of 6000 HALAL COIN (HC) to receive Airdrop 4th round = minimum of 7000 HALAL COIN (HC) to receive Airdrop 5th round = minimum of 8000 HALAL COIN (HC) to receive Airdrop 6th round = minimum of 9000 HALAL COIN (HC) to receive Airdrop 7th round = minimum of 10000 HALAL COIN (HC) to receive Airdrop ..... each round will increase 1000 HALAL COIN (HC) until it reaches the MAX minimum requirement of 100,000 HALAL COIN (HC).

BUY BACK PLAN 10 million HALAL COIN HC (10% of the supply) will be held in the burn address `simpleledger:qrpecurr373yscwtmw56wkw13j56jeuo3qplrl5kmd` All HALAL COIN HC distributed to this address from Airdrops will be used to buy back HALAL COIN HC to stabilize the price. All HALAL COIN HC tokens bought back will be burned deflating the token supply and increase token value.
